The Guidelines to Start FC/CC along-with its appendices A to D are enclosed herewith. You required to follow and implement the guidelines, meticulously. Failing which, the recognition granted to you histitute is liable to be cancelled.

For continuation to conduct the said FC at your Institute, the University, through Local Inquiconsmittee, shall carry out periodical inspection of your Institute after every three years from the date of ini Recognition of your Institute.

However, every year, in the first week of April, you are required to submit the application Continuation of Fellowship/Certificate Course in the prescribed format, along with the prescribed fees, continue the said FC & CC.
